BYOD & Office 365 Update

- Plan is still to deploy the windows-based software via virtual environment.
- There will be no need to be at a physical lab and not limited to one physical location
- SMC has license for Office 365 for students as of spring 2015. GAPPS is less suitable to District needs.
- Faculty currently piloting Office 365 which is called "1-Drive" (cloud name). All content is stored on cloud, not housed on Microsoft and not and SMC domain.
- Google vs. Office 365: Microsoft might be a more intuitive migration path as it has better accessibility while Google remains problematic, especially with accessibility.

Chair's Report:

- OEI CCMS planned to be announced end of December. More details and tracking of updates can be found on the OEI website (info & links on FAC 101)
- ISC student survey: 704 students replied out of a pool of 32,000 who received the survey.
- ISC plans to do a follow-up survey. Time TBD.

Ongoing Projects: Tutorina

Mona presented the need to address this project soon. A quick way to try this would be to do a small, short controlled pilot via outsourcing of tutoring services to vendor for 24/7 support for online students then assess outcomes and evaluate need.

• Other discussions included having on-campus tutors or faculty take on this task. Logistics and union issues come into play with trying to do this service in-house.
