## **Reports:**

- Christine Miller provided the committee with a status update on recent and upcoming eCollege enhancements and release schedules. Ability to hide threads to go live on 3/27. A new dashboard with updated look & feel including avatars will be released campus-wide as of winter 2016. There is a need for committee members to volunteer to test out upcoming enhancement in a sandbox which has been put into place. Please email Christine/Julie to request your sandbox accounts as soon as possible so we can begin the vetting process, get oriented to the new design and, if need be, send comments back to eCollege.
- OEI Southern California Academic Senate Saturday March 21 Conference Report: (Sal, Julie, Jenny & Pete): Discussion focused on potential "disruption" if SMC migrates to the CCC OEI CCMS Canvas. OEI contract has yet to be signed. Details on if other nonexchange CCC's will be allowed to use Canvas and what price points will be made available and what items (i.e. 24/7 helpdesk) will be included or a la carte.
- Additional OEI prompted changes: CCC Confer (product name Elluminate) is being retired and they are moving to Zoom video conference product.
- Advisory to DE programs, the Accreditation team could put a heavy focus on institution's DE programs if that institution does not have other pressing issues. It was suggested that institutions not make claims that cannot be evidenced about their DE programs.
- Distance Ed Update (Julie): May @ONE foundation class application period closed on 3/25. @ 40 faculty applied over half of which are current, some long term, online FT and PT faculty.
- Glendale College now certifies all online faculty. It is an in-house program called OWL (Online Wired Learning). Certification is a six-hour process.

• Chair Veas suggested interested committee members attend an upcoming Academic Senate meeting to update them on the OEI status as our committee moves toward certification and best practices for online faculty and how the OEI trends might tie to SMC's discussions on readiness.
