Chairs' Report:

Discussion of recent southern California region Academic Senate retreat (online education regionals) on Saturday, April 9, at Glendale College: "What to Expect When You're Expecting.....The Accreditation Visiting Team and Distance Education Review". Areas of interest include "regular and substantive interaction between student and teacher" and accessibility. Does the DE committee want to author a policy/District recommendation on "Regular Effective Contact (aka REC) for online classes? Consensus to explore the development of such a policy further at next meeting.

Accreditation Guest Presentation (Erica LeBlanc):

The majority of the meeting was devoted to a robust and thoughtful discussion on the self-study prompts which tie directly into Distance Education. Sample of discussion topics are below.

Standard I: "Mission, Academic Quality and Institutional Effectiveness, and Integrity".

Specific question – "how does the institution verify that the DE/CE students receive a
course syllabus that includes student learning outcomes, and that individual sections of
courses adhere to the course objectives/learning outcomes, objectives/learning
outcomes". The committee confirmed that the process and expectations remains
unchanged; online and hybrid courses are treated equivalently to on-ground, face-toface courses.

Standard II: Student Learning Programs and Support Services – Instructional Programs.

• What stakeholders are consulted about the choice of student in which the institution offers DE/CE and how are they consulted? DE classes go through the curriculum review

process to address delivery modality including how to address the pedagogy effectively in the online classroom.

Due to time constraints, the committee was unable to consider all of the DE-related accreditation standards and prompts. Erica LeBlanc will follow up with the committee, as necessary, in order to address additional questions that arise in finalizing the accreditation self study.

New Business:

Also due to time constraints, the committee postponed consideration of Intelecom's online video resources, which will be addressed at the next meeting.
