IV. SUPERINTENDENT'S REPORT

 Management Association Report: Management Association President Al Vasquez expressed happy new year wishes on behalf of the Management Association.

Updates

- Winter 2011 Enrollment: Enrollment is about the same as winter 2010 and is on target as planned; of the course fill rate is over 100 percent, so classes are completely filled. For Spring 2011, a record low number of students were dropped on the "drop for nonpayment" day.
- State Budget: Governor Brown presented a "painful" budget proposal for 2011-12. In order to close the \$25.4B budget gap (\$8.2 in 2010-11 and \$17.2 in 2011-12) and have a \$1 billion reserve, the Governor proposed \$12.5 billion in cuts and is relying on the residents of California to extend \$12 billion in revenue extensions and modifications, which are expiring, in a special June election. There is also \$1.9 billion in savings from other solutions, reorganization, and program efficiencies.

The governor acknowledged that the only major portion of the State budget that has been significantly reduced since 2007-08 has been K-14 education through Prop 98. However, only K-12 funding was held level for 2011-12. The Community College side was cut \$400 million. Both the UC and CSU systems were cut \$500 million.

For the Community Colleges:

- No mid-year cuts
- Student fee increase of \$10 per unit (+38%)to bring the enrollment fee to \$36 per unit
- Fee increase revenue of \$110 million used to fund 1.9% growth (22,700 FTES)
- Categorical funding reductions and flexibility continued
- Property tax (\$33.4 million) and student fee (\$18.7 million) shortfalls are backfilled in general fund
- Cal Grant program is fully funded
- Additional \$129 million inter-year deferral. Total deferral is now \$961 million
- \$400 million for apportionment reductions and reforms. A task force has been formed to develop specific census date reforms, to develop incentives for colleges to ensure course offerings for transfer and vocational skills, and to assist students with course completions. This \$400 million represents an approximate reduction of 7 percent. Although the CC funding was held "flat" in 2010-11, it was cut \$520 million in 2009-10. With the proposed cut for 2011-12, the CC will have suffered over \$900 million in reduced funding. In addition there has not been any COLA in three years.

The Governor's initial budget proposal is contingent on the public choosing to extend taxes in a special election. Otherwise the reductions will essentially be doubled.

RECOMMENDATION NO. 1

SUBJECT: 2011-2012 NONRESIDENT TUITION RATE

SUBMITTED BY: Superintendent/President

REQUESTED ACTION: It is recommended that the Board of Trustees adopt and establish the

2011-2012 nonresident tuition rate as follows:

a. Non-resident tuition rate shall be \$217 per semester unit.

b. The capital outlay recovery surcharge shall be \$22 per semester

unit

BACKGROUND:

Education Code Section (ECS) 76140 requires each district governing board to establish the nonresident tuition fee not later than February I for the succeeding fiscal year. Seven options are provided for calculation of the non-resident tuition rate, as represented in the following chart.

Option I	Statewide Average Cost Calculation	\$176
Option 2	District Average Cost Calculation	\$174
Option 3	Average Cost Calculation for District with 10% or more noncredit FTES	N/A
Option 4	Contiguous District (proposed fees not yet reported)	N/A
Option 5	No more than District Average Cost, no less than Statewide Average Cost	N/A
Option 6	Highest Statewide Average Statewide Average Cost Calculation 2006-2007 through 2011-2012	\$190
Option 7	No more than 12 Comparable States' Average Tuition	\$280 Maximum

Options 6 and 7 were established as a result of the recent approval of AB 2297 (Brownley). For 2011-2012, the lowest possible nonresident tuition rate for SMC is \$174 per semester unit, and the highest possible nonresident tuition rate is \$280 per semester unit. Option 7 was used to determine SMC's 2011-2012 nonresident tuition rate of \$217 per semester unit. (This represents an increase of \$31 from the 2010-2011 rate of \$186 per semester unit.)

Education Code Section 76140 also authorizes districts to charge a capital outlay recovery surcharge so that districts may recover a prorated share of their capital outlay expenditures. (The recommended capital outlay recovery surcharge for 2011-2012 constitutes a \$14 per unit decrease from the 2010-2011 capital surcharge.)

Using the new Option 7 enables SMC to calculate the tuition rate in conjunction with the capital outlay surcharge (which fluctuates from year to year) so that the focus can be upon the total cost for students rather than its individual components. The total of the recommended nonresident tuition rate and capital surcharge represents a net increase in the cost of attendance of 7.7 percent per semester unit.
