IV. Old Business

1. Kaiser's written response regarding Kaiser plan(s) options for part-time faculty was provided to committee members:

On Oct. 16, 2013, Kim Hauk, Account Executive, Alliant Insurance Services, received via email the following:

"Kim,

This is to confirm that we are not able to offer both the current plan direct plan with Kaiser Permanente and the CalPERS plan to the same population.

I am not 100% of the rules for CalPERS but I do not think you are able to offer any other non-CalPERS plan alongside their offering.

The rationale behind why we cannot offer both plans is because our risk remains the same but we would be competing with ourselves and the client would then be able to game the rates. I believe this is common stance with all other carriers as well. For groups that would like to move into or out of CalPERS, we do have a break in breakaway policy that applies.

Discussion:

The term, 'same population' is a critical point: Right now the adjunct faculty are not eligible for CalPERS benefits. That is why we are allowed to offer them the Kaiser Plan that is offered to the Project Managers. If we allowed them (adjunct faculty) into the CalPERS plans, they would be in the 'same population' (i.e., they would be in the CalPERS population) and would not be able to participate in the current Kaiser plan.

There are two colleges in the system that have the CalPERS plan and a Kaiser plan; that is where the Faculty Association got the idea, but those colleges are not in Southern California. It seems that the Southern California Kaiser has its own policies.

Fran Chandler reports:

The Associated Faculty leaders agree to drop this issue at this time. They no longer expect the Committee to investigate this further, and are satisfied it is not possible to have this done.

2. CSEA's response regarding Lasik/Laser Surgery.

Willis Barton reports:

CSEA discussed it and agreed that if it is going to affect either the members and or the District significantly on a financial basis, CSEA would not pursue it at this time. CSEA reserves the right to reintroduce it in the future (as part of a plan).

3. ASCIP/Delta Dental Plan Options.

We will not be able rebid a new dental PPO option for 2015 at this time. The earliest time to start the process would be the end of May 2014.

Important dates and information to consider:

1. May 2014:

The rebidding of the dental PPO option for 2015 cannot begin earlier than May, 2014. Insurance carriers need to see a minimum of six (6) months of usage immediately prior to the bid period. Rates are developed based on current claim use.

- 2. August 2014:
 - a. Rates for the upcoming Plan Year are typically published in August of the prior year (i.e., rates effective January 01, 2015 will be published in August 2014).
 - b. Decision to change dental plan(s) must be made by <u>end of August</u> <u>2014</u> in order for a new plan to be included as an option for Open Enrollment for Plan Year 2015.
- 3. September 2014:

Open Enrollment for Plan Year 2015 will start sometime in September 2014.

HR resource staff reminded the Committee that typically the first meeting of the Fall 2014 semester would occur in September, a date that would be too late to effect a change due to the Open Enrollment schedule. A special meeting was recommended to be scheduled in August 2014.

- 4. Goal of August 2014 meeting:
 - a. Reviewing the options proposed by ASCIP's dental plan options; and
 - b. Recommend an action based on that review.

It is anticipated that adoption of a new PPO plan similar to the *Delta Dental PPO Plus Premier Plan* as offered by ASCIP for 2014 would be a win-win (the district and employees will save money under the PPO/Enhanced plan).

Committee was reminded that a decision *must be made* during the August meeting if a change in PPO plan is desired.

Committee agreed to schedule a tentative meeting in August 2014 during Flex Week. The meeting would be tentative based on receiving plan and rate information from ASCIP in time for the meeting. Information received from ASCIP will be disbursed to the Committee immediately upon receipt.
