How do we address the issue with the letters of reference? There is still resistance to reducing the number of required letters to 1 or zero. It is not feasible to do them at the time of committee interview. Due to system limitations they would need to be uploaded manually by HR. Can they be submitted prior to applications being completed by the applicant? No. The
letters are not confidential until the applications are locked. One possible solution is to make the due date to applicants sooner than the reference writer. For example, if the recruitment has a close date of $2 / 15$, make the deadline for applicants $2 / 1$ and the deadline for reference letters $2 / 15$. The People Admin program SMC uses is several versions old. Would upgrading solve the problem? Unknown. Sherri will do some research.

Apart from the system related concerns, there is also concern about the validity/confidentiality of the letters (i.e. written on letterhead, includes signature, proper e-mail addresses, etc). Right now it is up to the search committees during screening to determine whether or not to accept.

Per Peter Morse, the language in the new FA contract reads Faculty Chair and does not distinguish between Department Chair and Faculty Leader. The committee can now finalize the changes to the language in the AR to mirror the references in the FA contract.
