#### II. Public Comments

Jose Cue, Philip Lantz, Beatriz Magallon, Janet Robinson, and Sara Nieves-Lucas provided public comment regarding the Global Citizenship GE requirement, expressing support for Global Citizenship and the Global Council, but keeping Global Citizenship as a local GE requirement would present an additional barrier to students.

It was also noted if Global Citizenship was no longer required, counseling is committed to leaving the "GC" identifiers on the local GE sheet, counselors would continue to encourage students to take Global Citizenship approved courses in the applicable GE areas and are looking to propose a Global Citizenship Certificate of Achievement.

Esmeralda Hernandez, Associated Students Director of External Affairs provided comment from a student perspective – many students spoken to didn't specifically seek a Global Citizenship course for GE but had completed the requirement through other areas of GE that are approved for Global Citizenship.

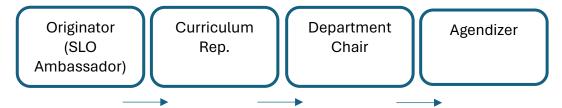

Proposed streamlined META workflow for Course Student Learning/Program Learning Outcomes (CSLO/PLO) mapping.

## **Program Outcomes Mapping Proposals**

Currently, a program change proposal in META must be reviewed and forwarded by several individuals before it can be added to the meeting agenda. Furthermore, in order to map a program's (program-level) learning outcomes to the included course-level learning outcomes, one must use the current program change proposal workflow. Given the tens and tens of programs that need to be mapped, the META pipeline could be overwhelmed by program change proposals as part of the CSLO/PLO mapping project.

To help alleviate the burden of so many anticipated proposals, the following simplified workflow for **program outcomes mapping proposals** is suggested. Each box below identifies an individual who would need to review and approve the PLO mapping proposal before it would appear as a **consent agenda** item on the Curriculum Committee agenda:



The criteria for using this simplified workflow would be as follows:

- 1. The proposal is to map program learning outcomes to course-level outcomes; or
- 2. The proposal is to separate a PLO paragraph into distinct, numbered PLO sentences without any changes to the meaning or intent of the PLOs; or
- 3. A combination of the two proposal types above.

#### **Course SLO Change Proposals**

The curriculum committee may also want to consider a similarly streamlined workflow for a proposed change to a course-level learning outcome under the following conditions:

1. The proposal is to correct a typo, grammatical, or syntactical error in one or more CSLOs *without* any changes to the meaning or intent of the CSLO(s).
