A. Affirmed Names (B. Magallon)

N. Donahue presented the resolution (Non-Binary Gender Option on CCC Apply) that he had written for the State Academic Senate, which was the only equity and diversity resolution passed at Fall Plenary. There was then a long discussion on why other colleges have affirmed names, but SMC does not. It was pointed out that affirmed names also need to be used in Canvas. Issues with gender options on he EEO survey and the lack of gender neutral being listed on the campus map, something the Equity and Diversity committee has been asking for three years, were also brought up.
