IV. SUPERINTENDENT'S REPORT

- Management Association Update: SMC Management Association President Erica LeBlanc reported that Dean of Campus Security, Student Health and Safety, Al Vasquez and his team were the winners of the "Applause Award" for January.
- Recognition of Mark Kessler, SMC Police Officer: The Board of Trustees recognized SMC Police Officer Mark Kessler, who recently received the Santa Monica Elks Lodge Law Enforcement Officer of the Year Award. The award winner is selected from the five nominated by Santa Monica Police Department, FBI, Los Angeles Sheriff's Office, UCLA Police Department and SMC Police Department.
- Recognition of Karen Bancroft, Personnel Commissioner The Board of Trustees presented outgoing Personnel Commissioner Karen Bancroft a certificate of recognition for ten years of exemplary service. Her last meeting as Personnel Commissioner is February 17th.
- Updates:

Spring 2010 Enrollment: Vice President of Academic Affairs Jeff Shimizu reported that less than two weeks from the start of the spring semester, classes are already 97 percent full. Compared to the same time a year ago, enrollment is up by 11 percent on a fulltime-student-equivalent (FTE) basis, 6.5 percent by headcount, 7 percent in online classes, and 7 percent by out-of-state students.

State Budget: When Governor Arnold Schwarzenegger proposed last month a 2 percent growth funds for community colleges in the 2010-11 budget, college officials statewide were "ecstatic." But recent briefings by state officials have revealed that the 2 percent growth proposal is unlikely to materialize because of a projected property tax shortfall statewide and doubts that federal stimulus money will come through to pay for the growth.

SUBJECT: **REFINANCING OF CERTIFICATE OF PARTICIPATION**

SUBMITTED BY: Superintendent/President

RESOLUTION: A RESOLUTION OF SANTA MONICA COMMUNITY COLLEGE DISTRICT APPROVING, AUTHORIZING AND DIRECTING THE EXECUTION AND DELIVERY OF LEASE FINANCING DOCUMENTS, AND AUTHORIZING AND DIRECTING CERTAIN ACTIONS WITH RESPECT THERETO AND DECLARING ITS INTENTION TO REIMBURSE ITSELF FROM THE PROCEEDS OF ONE OR MORE TAX-EXEMPT FINANCINGS FOR CERTAIN EXPENDITURES MADE AND/OR TO BE MADE IN CONNECTION WITH THE ACQUISITION, CONSTRUCTION, RENOVATION AND EQUIPPING OF CERTAIN CAPITAL IMPROVEMENTS

WHEREAS, the Board of Trustees (the “Board”) of the Santa Monica Community College District (the “District”), working with the Los Angeles County Schools Regionalized Business Services Corporation (the “Corporation”), is proposing to participate in a capital projects program under which the Certificates of Participation (Los Angeles County Schools Pooled Financing Program), 2010 Series A (the “Certificates”) are to be executed and delivered by the District in one or more subseries; and

WHEREAS, in connection therewith, the District wishes to proceed with the lease refinancing of certain capital improvement projects for the District described in the Lease (as defined below) to include, generally, capital improvements and various items of equipment (the “Project”), which Project was initially financed with the proceeds of \$24,905,000 aggregate principal amount of Refunding Certificates of Participation (1999 Series A) (the “Prior Certificates”); and

WHEREAS, said refinancing will be accomplished by the sale, execution, and delivery of Certificates, which may be executed and delivered at separate closings in one or more series and on a pooled basis along with any other school district, community college district or other local agency approved by the Corporation, to RBC Capital Markets Corporation, as lead underwriter, and E. J. De La Rosa & Co., Inc. and/or such other co-underwriter or co-underwriters as may be selected (collectively, the “Underwriters”); and

WHEREAS, the District is authorized pursuant to the Education Code of the State of California to provide for the execution and delivery of certificates of participation, which evidence proportionate interests of the owners thereof in certain lease payments to be made by the District; and

WHEREAS, the Corporation may assist local agencies in financing and refinancing the purchase of land and improvements, the acquisition and construction of new and renovation of existing facilities of the District and the acquisition of infrastructure improvements and equipment for use by the District; and

WHEREAS, the District is a community college district duly organized and existing under the laws of the State of California; and

WHEREAS, there have been presented to this meeting of the Board the following documents:

Proposed form of Lease Agreement (the "Lease"), by and between the District, as Lessee, and the Corporation, as Lessor;

Proposed form of Site Lease (the "Site Lease"), by and between the District, as Lessor, and the Corporation, as Lessee;

Proposed form of Trust Agreement (the "Trust Agreement") by and among the District, and any other school district, community college district or other local agency approved by the Corporation, and The Bank of New York Mellon Trust Company, N.A. (the "Trustee");

Proposed form of Assignment Agreement (the "Assignment Agreement"), by and between the Corporation and the Trustee;

Proposed form of Certificate Purchase Agreement (the "Purchase Agreement"), by and among the District and any other school district, community college district or other local agency approved by the Corporation, the Corporation and the Underwriters, and approved by the Treasurer and Tax Collector of the County of Los Angeles (the "Treasurer");

Proposed form of Continuing Disclosure Agreement (the "Continuing Disclosure Agreement"), by and between the District and the Trustee;

Proposed form of Preliminary Official Statement (the "Preliminary Official Statement") with the respect to the Certificates; and

Proposed form of Escrow Instructions (the "Escrow Instructions") of the District directed to U.S. Bank National Association as trustee with respect to the Prior Certificates.

NOW, THEREFORE, the Board of Trustees of the District resolves as follows:

The form, terms and provisions of the Trust Agreement are hereby approved and any of the Chair of the Board, Vice Chair of the Board, the Superintendent/President, the Executive Vice President, and any other officer designated in writing by the District to perform the obligations set forth herein (each an "Authorized Signatory" or "Authorized Representative") is hereby authorized and directed on behalf of the District and in its name to execute and deliver to the Corporation, the Trust Agreement in substantially the form presented to and considered at this meeting of the Board, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

In accordance with the terms of the Trust Agreement, and as shall be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution of the Purchase Agreement, the Board does hereby authorize the execution and delivery of the Certificates, evidencing proportionate interests of the owners thereof in lease payments due from the District under the Lease and lease payments of such other entities under respective lease agreements participating on a pooled basis, if any, and authorizes the sale of such certificates in accordance with such Purchase Agreement, and resolves that such certificates be executed and delivered in accordance with, and secured by the Trust Agreement.

The interest rate with respect to the Certificates shall be established in the Purchase Agreement, which shall, in no event, exceed 6% per annum, and shall be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The form, terms and provisions of the Lease are hereby approved, provided that (i) the aggregate principal amount of the Lease does not exceed twenty million dollars (\$20,000,000); and (ii) the term of the Lease will not mature later than 2024. Any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute and deliver to the Corporation, the Lease in substantially the form presented to and considered at this meeting of the Board, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The form, terms and provisions of the Site Lease are hereby approved and any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute and deliver to the Corporation, the Site Lease in substantially the form presented to and considered at this meeting of the Board, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The form, terms and provisions of the Purchase Agreement are hereby approved, provided that the discount on the purchase price of the Certificates to the Underwriters (excluding original issue discount) shall not exceed 1.00% of the aggregate principal amount of the Certificates. Any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute the Purchase Agreement, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The form, terms and provisions of the Continuing Disclosure Agreement are hereby approved and any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute and deliver to the Trustee the Continuing Disclosure Agreement in substantially the form presented to and considered at this meeting of the Board, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The form, terms and provisions of the Escrow Agreement are hereby approved and any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute and deliver to the Corporation, the Escrow Agreement in substantially the form presented to and considered at this meeting of the Board, with such changes therein, however, as may be approved by any Authorized Signatory, such approval to be conclusively evidenced by such officer's execution thereof.

The officers of the District are hereby authorized in conjunction with the Underwriters to prepare and distribute a Preliminary Official Statement and an Official Statement in connection with the offering and sale of the Certificates. The officers of the District are authorized to provide information regarding the District in connection with the preparation of such document or documents. The proposed form of Preliminary Official Statement with respect to the Certificates in the form on file with the Board is hereby approved. The Underwriters of the Certificates and the officers of the District are hereby authorized to distribute to persons who may be interested in the purchase of the Certificates a Preliminary Official Statement in substantially said form with such changes therein, deletions therefrom and additions thereto as may be approved by the District or by Hawkins Delafield & Wood LLP ("Special Counsel"). Upon approval of such changes by the District as evidenced by execution of a certificate, the Preliminary Official Statement shall be deemed final as of its date, except for the omission of certain information as provided in and pursuant to Rule 15c2-12 promulgated under the U.S. Securities and Exchange Act of 1934, as amended. Any Authorized Signatory is hereby authorized, for and in the name of and on behalf of the District, to approve a final Official Statement for the Certificates authorized hereby, in substantially the form of said Preliminary Official Statement, with such insertions and changes therein as the District or Special Counsel may require or approve, such approval to be conclusively evidenced by the distribution and delivery thereof. The Underwriters of the Certificates and the officers of the District are hereby authorized and directed to deliver copies of the final Official Statement to all actual purchasers of the Certificates.

Any Authorized Signatory is hereby authorized and directed on behalf of the District and in its name to execute and deliver any trust agreement, lease agreement or other certificate or agreement in the form of such trust agreement, lease agreement or other certificate or agreement executed and delivered in connection with the Certificates.

The Treasurer may, at the direction of the District invest and/or direct the investment of the proceeds of the Certificates and any other funds held under the Trust Agreement in accordance with the Trust Agreement and in compliance with Sections 53601 and 53608 of the California Government Code and Los Angeles County policy governing the investment of such funds.

This Board hereby authorizes and directs any Authorized Signatory to cause notices of the proposed sale and final sale and itemized costs of issuance of the Certificates to be filed in a timely manner with the California Debt and Investment Advisory Commission pursuant to California Government Code Section 8855.

Any Authorized Signatory and the Secretary of the Board are hereby authorized and directed to attest to the signature of any other Authorized Signatory, whenever required or advisable for the transactions contemplated by this Resolution. Any Authorized Signatory, acting individually, is hereby authorized and directed to execute and attest such further documents, instruments, deeds of trust and certificates as may be deemed necessary or advisable by Special Counsel, to accomplish the purposes of this Resolution.

All actions heretofore taken by any officer or agent of the District with respect to the execution and delivery of the Certificates or in connection with or related to any of the agreements referenced herein or the financing of the Project, are hereby approved, confirmed and ratified.

This resolution shall take effect immediately upon its adoption.

COMMENT: This action will result in the refinancing of the current Certificates of Participation (COP) which cover the cost of construction for the parking structures. Payments for the current Certificates of Participation are financed by parking permit fees, which were sufficient prior to the implementation of free parking at satellite campuses. Currently the College is running an average of 12% deficit for the past four years, with this refunding, the College will be able to balance the payments and build up a reserve for future funding deficiency. The Los Angeles County Schools will act as administrator for this program.

Under Education Code Section 17430 these transactions are structured as lease-purchase agreements between the District and Los Angeles County Schools.

- * The Broad Stage is bringing the highest caliber artists to Santa Monica College, including Baryshnikov, Basil Twist, Juan Diego Florez, Placido Domingo, Angel Romero, just to name a few.
- * Ticket sales have been running at an average of approximately 85% of capacity.
- * People in the arts - from New York to London - are talking about the Broad, and they all want to be a part of it. This is a great coup for the College. And we are only in the second season!
- * We are developing partnerships with organizations that range from LA Opera to the Old Vic in London.
- * There have been several notices in the New York Times mentioning Santa Monica College favorably. The reviews in the LA Times have consistently favored the theater.
- * Next season we will continue the path of diversity - and will present opera, theater, jazz and dance, with possibilities ranging from The Royal Shakespeare Theatre to Esperanza Spaulding.
- * Our outreach programs continue to grow. This season we had a master class with Savion Glover, one with Angel Romero in close association with the Music Department; student matinees for Shakespeare and Basil Twist. We will also present a special student performance of August Wilson's The Piano Lesson.
- * The SMC student body is a prime beneficiary of our outreach, with first priority to all student events, and \$20 tickets to all performances.
- * Eli and Edythe Broad continue to be very involved, and the Broad's Chair, Austin Beutner, was just named Deputy Mayor and Chief Executive for Economic and Business Policy for the City of Los Angeles. This is a tremendous opportunity for both the theater and the college.
- * The Board has grown from the initial membership of four to the current level of 18, all of whom are actively involved in improving the membership, support and quality of operations.

SUMMARY: The George Yardley Company was the original installer of the proprietary Phoenix Control System in the Science Building, and they are also the only factory authorized contractor, installer and maintainer of Aircuity OptiNet Multiplexed Sensing System in the Los Angeles area.

The George Yardley Company will install, integrate, and commission the Aircuity OptiNet Multiplexed Sensing System in the Science Building in order to monitor the quality of the indoor laboratory environment and to control the airflow based upon substantiated need. This will allow the campus to operate the building at an estimated average of 4.4 air changes per hour versus the current average of over 8 air changes per hour. The new sequence of operations would also enable the ventilation levels to go to as much as 20 air changes per hour for thermal loads, or air quality incidents within an individual laboratory thus enhancing student and faculty safety and comfort. College Maintenance Department will be able to log onto a password protected webserver to view and graph real-time and historical trending in any of the monitored spaces.

Annual Sensor Services and Data Services are included for 5 years from commissioned date. This covers the normal warranty period and also all sensor calibration and exchanges for five years.

The cost of this project is \$392,274 with incentive of \$180,077.32 from Southern California Edison the final cost for the College is \$212,196.68. The savings from this project for the next 10 years is estimated \$1,367,214.00, which makes this a viable project. The payback period is 1.7 years.

REQUESTED ACTION: It is recommended that the Board of Trustees approve the contract with CO ARCHITECTS for initial programming and concept design of the Information Technology Relocation project for \$140,000, plus reimbursable expenses.

FUNDING SOURCE: Measure AA

SUMMARY: This project will relocate Information Technology including Network Services and Telecommunications to the south end of the Library in the space currently occupied by the Library Village temporary building.

Before the 1994 Northridge Earthquake, Information Technology was located in the original Science Building. That building was severely damaged and Information Technology was quickly relocated to a new third floor area of Drescher Hall. The new location did not have the proper infrastructure for computer servers including fire protection and air-cooling. The college's use of computer technology has grown greatly since 1994 and the facilities in Drescher Hall have been unable to support the growth.

In the new Master Plan, Drescher Hall is scheduled for a major renovation with a new bookstore, retail and food services planned for the first floor and modernization and expansion of the academic facilities on the upper floors. The Information Technology functions are secure, back of house operations that are not compatible with the planned future of the building. In addition the construction process could affect electrical and data network feeds that come into the building and could potentially disrupt the critical computers in the data center.

Information Technology will join the current Media Center and campus telecommunications network center to create a single technology infrastructure at the south end of the Library complex.

CO Architects are nationally recognized experts in academic, research lab and healthcare planning and design. Their clients include seven campuses of the University of California, Claremont Colleges, Coastline Community College District, Los Angeles Community College District and the universities of Iowa, Texas, Washington and Wisconsin.

At SMC they have designed the Science Complex and the Library, both of which have won multiple design awards. Since this complex is part of the Library and because the firm is known for their work on highly complex technical projects, they were selected for this project.

The process to solicit architects began with mailings to 115 local firms, newspaper advertisements and web announcements. The District received 72 architect proposals, which is a record number. The initial submittals were screened and 24 firms were deemed qualified. Then a screening committee of faculty, classified staff and administrators selected 4 architects as finalists to be interviewed. The interview panel consisted of staff from Information Technology, Network Services, Media Center and Facilities.

This contract is for the initial programming and conceptual design for this project. At the completion of this phase, the building program, design concepts and a cost estimate will be presented.

Comment: The Division of State Architects (DSA) is now asking for a fully engineered fire sprinkler system to be included with the original building plans. Previously the general contractor would sub-contract this during the construction process and the cost of developing the plans would be included in the construction cost. Since the cost was originally planned for the construction budget this agreement does not result in any overall cost increase for the project. Although the District could contract with the architect for this service, it has chosen to contract directly through the engineering firm to avoid any additional overhead costs. In future projects this will now be included in the contract for architectural and engineering services.

**EXECUTIVE SUMMARY
FOR SANTA MONICA COMMUNITY COLLEGE DISTRICT
IN CONNECTION WITH PROPOSED
CERTIFICATES OF PARTICIPATION
(SANTA MONICA COMMUNITY COLLEGE DISTRICT)
(LOS ANGELES COUNTY SCHOOLS POOLED FINANCING PROGRAM)
2010 SERIES A**

The following is a brief summary of certain provisions contained in the basic legal documents for the District's Certificates of Participation, which are the: Lease Agreement, Trust Agreement, Site Lease, Assignment Agreement, Continuing Disclosure Agreement, Certificate Purchase Agreement and Escrow Instructions in connection with the proposed execution and delivery of Certificates of Participation by the Santa Monica Community College District (the "District"), which is proposing to participate in a program of pooled capital improvement projects. The following should not be considered a full statement of the terms of such documents as each are subject to revision, including by such changes as may be suggested by representatives of the District and others, and approved by an Authorized Signatory (as defined in the authorizing Resolution), such approval to be conclusively evidenced by execution thereof by such officers or their duly authorized representatives.

The Lease Agreement. The District is required under the Lease Agreement to make Lease Payments on each Lease Payment Date for the use and possession of the certain real property and certain improvements to real property of the District (collectively, the "Leased Property"). Lease Payments are to be made from any source of legally available funds of the District. Under the Lease Agreement, the District covenants to take all necessary actions to include Lease Payments in its annual budgets and to make the necessary annual appropriations therefor. The obligation of the District to make Lease Payments (other than to the extent that funds to make Lease Payments are available in the District's Lease Payment Fund and Reserve Fund under the Trust Agreement) is abated in whole or in part if the District does not have full use and possession of the Leased Property. Under the Lease Agreement, the District covenants to maintain or cause to be maintained with respect to the Leased Property rental interruption insurance to cover loss of the use of the Project as a result of damage or destruction, a standard comprehensive general public liability and property damage insurance policy or policies, a fire and lightning insurance policy with extended coverage, vandalism and malicious mischief insurance, insurance against loss and theft and title insurance.

The Lease Agreement terminates upon (i) the payment by the District of all Lease Payments and Additional Payments due during the term of the Lease Agreement, (ii) a default by the District and the election by the Corporation or the Trustee (as assignee of the Corporation) to terminate the Lease Agreement, (iii) the deposit of moneys with the Trustee comprising certain Permitted Investments in amounts sufficient to pay all Lease Payments as they become due, or (iv) the exercise by the District of its option to purchase the Leased Property.

Trust Agreement. The Trust Agreement will authorize the execution and delivery of Certificates of Participation on behalf of the District to be used by the Corporation to refinance the District's Refunding Certificates of Participation 1999 Series A (the "Prior Certificates"), which were executed in the principal amount of \$24,905,000 in February 1999 and are currently outstanding. The Prior Certificates were used to finance, acquire, construct and/or install certain improvements to real property of the District.

The Site Lease. In the Site Lease, the District leases to the Corporation the real property and improvements consisting of Leased Property, as defined in the Site Lease. The Corporation covenants in the Site Lease to use the Site solely for the purpose of operating the authorized improvements constructed thereon and to not assign its rights under the Site Lease, except as provided in the Lease Agreement without the consent of the District.

The Assignment Agreement. The Assignment Agreement is entered into between the Corporation and the Trustee, pursuant to which the Corporation assigns and transfers to the Trustee, for the benefit of the Owners, the rights of the Corporation under the Lease Agreement, including the right to receive Lease Payments under the Lease Agreement, the right to receive proceeds of insurance on the Leased Property and the right and remedies of the Corporation under the Lease Agreement to enforce payment of Lease Payments.

Continuing Disclosure Agreement. The District will enter into a Continuing Disclosure Agreement with the Trustee, as Dissemination Agent thereunder, pursuant to which it will agree to provide, or cause to be provided to the Dissemination Agent, certain information specified therein and to provide, or cause to be provided, in a timely manner notice of certain material events respecting the Certificates of Participation. These covenants are required to be made in order to assist the Underwriters in complying with SEC Rule 15c2-12(b)(5).

Certificate Purchase Agreement. Pursuant to the terms of the Certificate Purchase Agreement, by and among the District and any other school district, community college district or local agency approved by the Corporation, the Corporation and the Representative, the Certificates of Participation shall be purchased by the Underwriters pursuant to the Certificate Purchase Agreement. The Certificate Purchase Agreement incorporates particular covenants of the District with respect to acts and agreements of the District concerning the delivery of the Certificates of Participation.

Escrow Instructions. The District will issue Escrow Instructions directed to U.S. Bank National Association, the trustee for the Prior Certificates, which the District has proposed to refinance. The Escrow Instructions direct the Prior Trustee to establish an escrow fund and to deposit a portion of the proceeds of the Certificates of Participation. These proceeds will be applied by the Prior Trustee to pay principal and interest on the Prior Certificates.

Official Statement. The District will prepare a Preliminary Official Statement and an Official Statement in connection with the sale and delivery of the Certificates of Participation. The Official Statement describes the terms of the Certificates of Participation, the security for the Certificates of Participation and the District and the District's financial condition. The District will certify that the information regarding the District in Official Statement is accurate and does not contain any misleading information or untrue statement of a material fact.

The District faces several significant fiscal problems that must be addressed in the 2009-2010 and 2010-2011 fiscal years.
 1) Due to reductions in general apportionment and categorical funding resulting from reduced State and ARRA revenue streams, the District expects to drawdown on its reserves in both the 2009-2010 and 2010-2011 fiscal years.
 2) The extensive cash deferral mechanism in the State General Apportionment dispersal process could cause the District cash flow issues that may require external borrowing and additional borrowing related expenditures.
 3) The reduction in categorical funding has placed a significant strain on the General Unrestricted Fund. The program reductions in DSPS and Schedule Maintenance poses a significant problem as mandates and operation needs prevent the District from reducing expenditures in these areas to match the reduced funding from the State resulting in a shift of resources from the Unrestricted General Fund to fund these programs and related expenditures.
 4) With the reduction in Part-Time Faculty Insurance funding from the State coupled with the rising cost of Health and Welfare benefits for both current and retired employees, for whom the District covers 100% of cost, the District is expecting an increased percentage of the Unrestricted General Fund will be needed to cover these expenditures moving forward.
