

**Measure S Bond Program  
Project Category Listing**

This list identifies specific projects related to the categories in the approved bond language. A single project may be listed under several categories.

General Project Descriptions:

1. Development and implementation of facilities master plans and related requirements such as environmental impact reports and soils testing.
2. Demolition of temporary and/or obsolete facilities.
3. Installation and/or upgrading of emergency lighting, fire alarm, and security systems.
4. Roadways, walkways, grounds, parking lots and garages, and entrance improvements.
5. Signage for safety and public information.
6. Modernization and/or construction of new restrooms.
7. Financing/Refinancing of real property acquisition and improvement.
8. Acquiring related furnishings and equipment for all modernization, renovation, improvement and/or new construction project components.
9. The relocation and/or acquisition of temporary facilities during the modernization, renovation, improvement and/or new construction of project components as necessary to maintain educational programs in operation during construction.
10. Acquiring and/or refinancing real property for future classroom, student service, child care and/or other uses.
11. Acquiring land including but not limited to contiguous parcels, making site improvements thereon and/or constructing additional facilities thereon, for the purpose of expanding instructional programs to meet future educational demands of District students.

12. Site acquisition and improvements in the District for field space, especially women's soccer, in order to make available a complete offering of District-provided programs in Health, Fitness, and Physical Education.
