This would give them experience and a feel for the meetings so we should invite them to the next meeting. Want to talk about the 5 year plan, adding several long term goals and encourage others to do as well. Student movements across the world are forming student unions and that way have real political protection and are very organized. Great that we are registering and taking action at SMC; we could swing any election if we organized. One thing that needs to be added to this report is that we have a Student Worker Union.

Brenda: The attendance sheet is updated. Also make sure to submit additions to the agenda by Wednesday night, Thursday morning at the latest so I don't get emails on Friday asking for additions and the agenda is already posted.

Marjohnny: Last year's Board approved monies for trash from zero waste. Working with Tom Corpus, getting \$5,000 back from recycling department for a service that was already bought. How much money would the AS be willing to use on buying back books from students?

DJ: Challenge both Cameron and Jasmine D. from using my name in your Director's Reports especially if they are falsely reported. I did tell you to take a marketing and advertising class so you know to advertise an event 72 hours in advance. There was no funding for materials to make signs- you need to provide that yourself.
