### XI. Discussion Items

11.1 Reviewing the Big Blue Bus Contract (Ty Moura, AS President).

**Ty**: I have been trying to get a hold of the BBB contract to see how much we are legally obligated to do but I have been having some trouble with it. We found out that we have a gentleman agreement in which we pay 50% of the BBB tab. There is no way for us to know whether we are paying 50% or 60% or even 100%. I would like for us to start tackling this issue.

**Inayat**: At finance meeting, George said that the past few years we have been paying more than 50% and it has been increasing every single year. This contract is between the district and bbb. I doubt there is any language in that contract that says the as will pay an amount. It is just a verbal agreement. George has caught that and has worked with the district to be down for 50%. When this contract comes we need to put language in the AS role and the language should say 50% or lower.

Ty: Making a written agreement between us and the district is necessary.

**Michael**: We should put in the language in the fiscal policy that the district make a proposal bring it here and show is the contract. It will stay in restricted fund but we put that if it is over a certain amount, then they have to do the process.

11.2 Installing a point system for activities (Michael Greenberg, Publicity).

**Michael**: We should have a currency system and the AS is the bank. You can earn currency for doing as related things. You can accumulate those and buy things from the AS office. By attending an AS cosponsored event you will earn 2 AS bucks. The kinks would have to be worked out.

**Inayat**: I think it would be a great idea for events. They would have to be for the entirety of the event.

Cassandra: I think the events are childish and I don't want to foster it.

Michael: They will be able to choose from many things and go to the ones that interest you.

**Jasmine**: I think the easiest way would be actual tickets that have our logo on it.

Okky: Experiment with it and see what happens.

**Alex**: I am more of a proponent of people doing something because they want to do it and not for rewards.

Ty: This may seem out of order but it's not. Just bear with me. Michael, how did you get involved with AS?

Michael: March in March

Ty: Why?

Michael: Because it was \$10 and a trip to Sacramento

Ty: That's my point.

**Inavat**: On a community college campus, there is minimal school spirit.

**Jasmine**: We have to lure them with a benefit that eventually traps them with AS. It might create a conflict with the clubs. If we do give out things, they have to be attached to AS and not something detached like a USB.

Cassandra: There should definitely be something with Athletics.

Benny: When we do elections, the elections that bring out the most people are the ones that

**Cassandra**: I think to initiate students to understanding AS is a great way to do that. **Maya**: I do think it is a good idea. Actual tickets are easy to lose and unsustainable.

Michael: Logistics are to be worked out.

**Ty**: We will set up an ad hoc committee called "AS Currency" in which the director of publicity is the chair and ICC Communications Officer is the vice chair. I highly recommend that you write the proposal in the form of a resolution.

11.3 Serving food during AS meetings (Ty Moura, AS President).

**Inayat**: Food is such a huge motivator. Serving food after this board meeting, I think people would just stay for the food. Maybe at the end it would work but at the same time, I don't think people would listen who come for only food.

**Cassandra**: Food would not foster the appropriate meeting environment.

**Michael**: I agree with the concept but I don't think the food is the right incentive. I think a different kind of incentive like the point system is better.

**Jasmine**: I don't want to turn the meetings for a social event. Our activities are social events.

### XII. Committee / Advisor Reports

**Ty:** Tomorrow things will be better organized. The pizza is flying fast. I highly encourage you all to help out.

**Discount Board (Cassandra):** Discount board will be resuming after UC apps are due.
