


4.1 Addressing violations


You have asked there is any basis to postpone or extend the Associated Students election scheduled for April 2-5, 2018

A. Section VI© (15) of 2018 of the election Code limits distribution of printed material to 500 pieces. To enforce this rule, the election code provided: "In order for the material to be distributed each item must be stamped by the election committee after it had been approved by the office of student life."

- B. Enforcement of the stamping requirement would have prevented candidates from distributing printed material because personnel was not available to do stamping
- C. Upon submission of material could not be distributed without the required stamp. This action was taken by the office of student life to prevent unfairness to any candidate because enforcing of the rule would have prevented timely distribution of campaign material.
- D. All candidates were treated equally and no adverse action had been or will be taken against any candidate who distributed material without a stamp.


The failure to enforce stamping requirement does no compromise the fairness to validity of the election. The distribution of printed material is one of the many tool available to candidates to articulate their positon to the student body. All candidates were treated equally concerning the distribution of printed material. Elections are rarely halted or set aside because of issues related to campaigning by candidates. Instead, election challenges generally involve from participating in the election sufficient to affect the outcome of the election.

In addition, the election committee had not authority to change the date of the election. The election dates are set forth in the election code approved by the Associated Student Bard of Director on November 27, 2017. The Election Code sets forth the exclusive enforcement procedure in Section VI (F). The Election Committee has the following authority: (a) determine that no violation occurred; (b) determine that a minor violation occurred and issue a written reprimand; and (c) refer a complaint to the Campus Disciplinarian for formal disciplinary proceedings.

It is unfortunate that the Election Code set forth a stamping requirement that was incapable of being implemented. The Office of Student Life took prudent steps to ensure that is requirement did not interfere with the ability of any candidate to distribute printed material. The action helped promote- rather than hinder- a fair election."






