

2.1 Discuss and approve changes to Election Code

Came in with a compromise, 20 percent to spend on any paper material. Check over the minutes for the board meeting, discussion on what the directors talked about how money way being used and what the material was.


Amended: Adding cashed advance only for student fitting the criteria (low-income).. passed without objection
