# VII. Discussion Items:

- 7.1 Drafting sustainability questions for funding proposal application
  - Director of Budget Management David Duncan discussed the current issues with excessive waste from A.S.-funded events and the gaps surrounding sustainability caused by our current event approval processes. The committee discussed some potential ways that improving the A.S. funding proposal form can help address these issues. Concerns were also raised about the current complexity of the form - and how the A.S. can ensure that events are sustainable without unnecessarily complicating the current funding process.
- 7.2 Budget forecasting discussion
  - Director of Budget Management David Duncan discussed the current authorizations from the A.S. budget, including a list of the major expenses so far this year and the impacted status of the Basic Needs account.

# 7.3 Surplus policy discussion

- Associate Dean Thomas Bui discussed the importance of evaluating our board's values surrounding the prior year surplus. Each director discussed their personal priorities for evaluating surplus proposals.

  - President: Cecilia Jeong: Satellite campus outreach, supporting students' basic needs.

  - o ICC Vice Chair Zach Makari: Supporting international students, helping clubs.
- The committee briefly discussed the details and feasibility of some specific ideas that have been raised at previous meetings. The committee achieved a rough consensus to refer the discussion item to the full board for further feedback and discussion.
